## Articles of understanding for the EC / EYT / EOT 2019

Failure to submit this form duly signed, will disqualify you from participation or entry to the EC / EYT / EOT 2019 competition site

- All persons associated with the ERSO European Championships and the European Youth/Open Tournaments must adhere to the rules and guidelines outlined in the ERSO 2017/2019 Rule Book and Tournament Guidelines. The Articles of Understanding must be signed for each event by **each Participant and Head of Delegation**.
- All competitors must arrive at the competition site at least 30 minutes before the scheduled event. If a competitor does not respond by the third call for the event, he/she will be disqualified.
- Any questions concerning the rules or procedure of the tournament will be handled exclusively by the Head of Delegation and will be directed to the Tournament Director. Such questions should be made prior to the competitions.
- All participants agree to conduct themselves in a manner displaying good sportsmanship throughout the event. The national coach is responsible for seeing that the team members, coaches, parents and any other persons affiliated with the team conduct themselves accordingly. Severe cases of unsportsmanlike conduct are grounds for disqualification. Any inappropriate behavior on or off the site will result in an immediate expulsion of the person from the site and sent home with no chance of refund of monies paid. Local authorities will be called.
- Be advised that on the evening before the competitions, it will be understood that reasonable quiet shall prevail and be enforced throughout the residences. This will be the responsibility of all country coaches.
- Any interpretation of any aspect of these Articles of Understanding or any decision involving any of the aspects of the event will be rendered by the Event Committee. The Event Committee will render judgment in an effort to insure that the event proceeds in a manner consistent with the general spirit and goals of the event.
- By participating in the competitions, each competitor agrees that the decisions made by the judges and Event Committee will be final and will not be subject for review. Each competitor acknowledges the necessity for the judges to make prompt and fair decisions in the competition and each competitor waves any legal, equitable, administrative or procedural review of such decisions.
- Any competitor or coach that does not adhere to the terms and procedures of the "Articles of Understanding" may be disqualified from the event and automatically forfeit the right to any awards presented during the event. In addition, the competitor may also forfeit the opportunity to participate in any qualifying competitions and/or any future European competitions.
- Only athletes (skippers) and the coaches designated by their respective countries will have authorized access to the competition field, the practice areas and the designated locker room areas. No parents or spectators will be allowed.
- Anyone, not authorized, found in these areas will be escorted immediately out the building by security and refused access for the remaining championship term.
- I give permission for the ERSO and/or Host organisation to use any videos and/or photographs of myself taken during this event for non-commercial publicity, advertising or other promotional purposes.
- In consideration of the acceptance of this application, I hereby release board members and any persons associated with ERSO and/or Host organisation, as it's designated host federation and club, from all claims and causes of action arising from injury to the participant during this event, whether such injury is the result of negligence or some other cause. If medical attention is required for injury or illness while at the tournament, I give my permission for such medical care and I will be financially responsible. By signing this form I/we attest to this fact that I/we have a valid medical insurance coverage plan.
